We have been unable to take the children swimming since October 2019. Prior to the global pandemic the swimming baths were closed due to the roof being deemed unsafe and repairs being undertaken. There has been no provision for the school to attend swimming lessons for the whole of the 2020-2021 Academic Year. Assessments are based on the children's outcomes when they were in Year 4.
